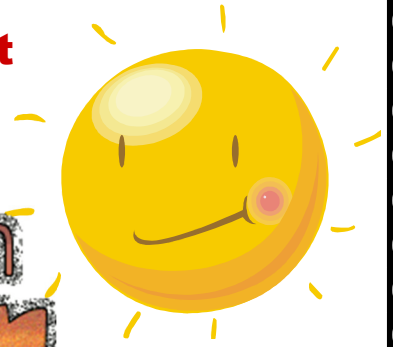

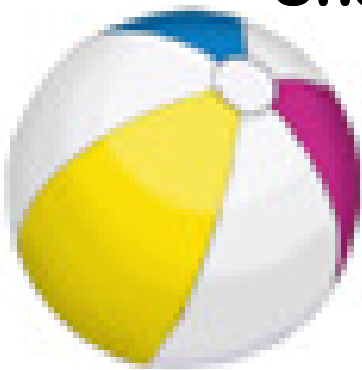

1. Handicap will be 90% of 220 within each division.
2. Entering averages to be used in this tournament shall be as follows:
 - a. Composite average of the last completed year 2021 - 2022, as found on bowl.com.
 - b. If none, composite average from 2020 - 2021, as found on bowl.com.
 - c. If none, current league average of 21 games or more – average verification must accompany entry form.
 - d. If none of the above, men will enter at a 200 average and women at a 180 average.
 - e. Failure to report correct average shall result in disqualification.
3. USBC certified. USBC 319a2, 319d and 319e are waived. USBC 319a3 and 319a4 will apply.
4. Participants must be current members in good standing of USBC. Must present current USBC card when checking in to bowl, if requested.
5. Tournament participation will be three games bowled on a handicap basis for each division. Bowlers may only bowl once. USBC Rule 315a.
6. All averages will be verified by tournament chairperson.
7. Prize money will be returned 100%. Entry fee will not be refunded on cancellation. USBC Rule 314.
8. Refunds will only occur for event cancellation.
9. Prize fund will be one in five places, also dependent on number of entries.
10. Payoff will be mailed to winners within 30 days following the tournament. Entry forms must be **legible and complete** to receive prize payouts. USBC Rule 309. **Please cash checks ASAP – uncashed checks will be deemed null and voided on 10/31/2023.**
11. **Results will be posted on Facebook, (Avocado200clubTournament), and posted at Mira Mesa Lanes within 15 days. Also provide your email to opt-into the tournament's email list.**
12. **Entries must be received by midnight, August 14, 2023.** Check-in time is 11 am; bowl at 12 noon.
13. Walk-Ins or late entries entry fee is \$45 and is based on lane availability. **Cut-off for walk-ins is 15 minutes prior to tournament**
