

Entry Fee \$25.00 per person, per squad.

Lineage \$8.25 Prize Fund \$14.25 Expenses \$2.50

- Entry closing date 10/28/25 at 1:30 p.m. \*Check-in ½ hour before each squad
- Bowler must have current USBC card \*Averages verified using bowl.com
- Walk-in's accepted if space available \*Any combination of bowlers 50 or over.
- Tournament winners based on total pins over average \*USBC certified
- Cash \$ prize \$ giveaways \$ at \$ each \$ doubles \$ squad
- Minimum of 50 prepaid doubles entries required by 9/26/25 to hold event
- Room rates: Sun Tue \$57.00 + \$15.00 Resort Fee + 13% tax = \$81.36/night

Fri – Sat \$122.00 + \$15.00 Resort Fee + 13% tax = \$154.81/night

#### TOURNAMENT RULES

- 1. All bowlers must have reached their 50<sup>th</sup> birthday on or before 10/26/25 to be considered a <u>qualified bowler</u>. Bowlers under the age of 50 must be legally married to or be the significant other of a <u>qualified bowler</u> in this tournament. Any bowler under the age of 50 who has bowled a squad in any of this Club's previous tournaments with a spouse or significant other is eligible to bowl any future squad of any of the Club's tournaments with another <u>qualified bowler</u>. All bowlers must have a current USBC card.
- 2. Entering averages to be used in this tournament shall be as follows:
  - A. Composite average, 2023-2024 as found on bowl.com.
  - B. If none, composite average from 2022-2023, as found on bowl.com.
  - C. If none, current league average of 21 games or more average verification <u>must</u> be submitted by email 3 days before event starts with most current information.
  - D. If none of the above, men will enter at a 200 average and women at a 180 average.
  - E. If your tournament average with us is 10 pins or higher after 9 games in the last 24 months you will be rerated to your tournament average. If you do not have 9 games with us and your composite average from 2024-2025 is 10 pins higher that average will be used.
  - F. <u>319a-3, average verification; 319c, rerate, shall apply.</u> All rules not covered herein will be covered by the current USBC playing rules.
  - G. Failure to report the correct average (before the end of the 1<sup>st</sup> game) shall result in disqualification.
- 3. Entry fee breakdown per <u>doubles</u> team: Lineage \$16.50, prize fund \$28.50, expenses \$5.00. Total doubles entry fee is \$50.00. Three (3) games of American Tenpins.
- 4. Entry fee breakdown for no tap singles: Lineage \$8.25, prize fund \$14.25, expenses \$2.50
- 5. Winners will be paid based on total pins over average.
- 6. All prize money will be returned 100% at the ratio of at least one in five entries. (One doubles team equals one entry.)
- 7. The same doubles team may compete more than once but may cash only once.
- 8. There shall be no refunds or carryovers for any reason. The SDCSDBC is not responsible for refunding money to the bowler nor their replacement(s).
- 9. All average changes made must be made by the Secretary.
- 10. Bowlers must check in at least thirty (30) minutes before squad time. Walk-ins will be accepted if space is available.
- 11. Entries must be filled out completely and legibly. Please print all information. Checks should be made out to: <u>SDCSDBC and mailed to Diana Shaw, 1312 McClelland St,</u>

- 12. Checks returned for any reason will be charged all bank fees Plus the amount of the check.
- 13. Prize checks not cashed within 6 months of issue date will be null and void and will not be reissued.
- 14. The Club maintains the right to refuse any entry.
