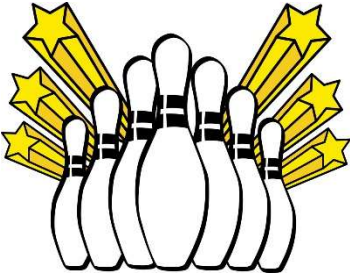

## TOURNAMENT RULES

1. All bowlers must have reached their 50<sup>th</sup> birthday on or before 5/16/26 to be considered a qualified bowler. Bowlers under the age of 50 must be legally married to or be the significant other of a qualified bowler in this tournament. Any bowler under the age of 50 who has bowled a squad in any of this Club's previous tournaments with a spouse or significant other is eligible to bowl any future squad of any of the Club's tournaments with another qualified bowler. All bowlers must have a current USBC card.
2. Entering averages to be used in this tournament shall be as follows: Averages will be verified using bowl.com
  - A. Composite average 2024-2025, as found on bowl.com. If your tournament average after 12 games is 10 pins or higher you will be rerated to your tournament average. Tournament averages are based on 12 games in the last 24 months. If you don't have twelve games with us in the last year and your current composite average is 10 pins or higher you will be adjusted.
  - B. If none, composite average from two (2) years prior, 2023-204, as found on bowl.com.
  - C. If none, current league average of 21 games or more – average verification must be submitted week before event. (**Current standing sheet and last recap sheet**).
  - D. If none of the above, men will enter at a 200 average and women at a 180 average.
  - E. Failure to report the correct average (before the end of the 1<sup>st</sup> game) shall result in disqualification.
3. USBC rules, 319a-3, average verification; 319c, rerate, will apply. All rules not covered herein will be covered by the current USBC playing rules.
4. Entry fee breakdown per doubles team: Lineage \$26.00, prize fund \$20.00 expenses \$4.00.
5. Total doubles entry fee is \$50.00. Three (3) games of American Tenpins.
6. Winners will be paid based on total pins over average.
7. All prize money will be returned 100% at the ratio of at least one in seven entries. (One doubles team equals one entry.)
8. The same doubles team may compete more than once but may cash only once.
9. There shall be no refunds or carryovers for any reason. The SDCSDBC is not responsible for refunding money to the bowler nor their replacement(s).
10. All changes to the recap must be made by the Secretary/Treasurer.
11. Bowlers must check in at least thirty (30) minutes before squad time. Walk-ins will be accepted if space is available. Anyone not checked in 15 minutes before squad time may lose their spot and forfeit their entry fee.
12. Entries must be filled out completely and legibly for both bowlers. Please print all the information. Please make checks payable to: **SDCSDBC and mailed to Diana Shaw, 1312 McClelland St, San Marcos CA 92069 or Zelle payments to SDCSDBC@gmail.com. And Email entry to sdcsdbc@gmail.com.**
13. Checks returned for any reason will be charged a check amount and all fees incurred.
14. Checks not cashed within 6 months of issue date will be null and void and will not be reissued.
15. The Club maintains the right to refuse any entry.
